¹ For the purpose of these regulations, the day before the beginning of the qualifying or the main draw shall be considered as a workday.

At combined ITF Pro Circuit events the Supervisor/Referee's fee shall be increased by 20%.

Depending on the tournament format, special fees and/or conditions may be approved.

APPENDIX

Assignments: The assignments of all the international events organised in Spain are handled exclusively by the Spanish Officiating Committee (CEAT) in coordination with the governing bodies and their officiating departments.

Fees and expenses:

- The Tournament is responsible for paying the fees and reimbursing all the expenses (accommodation, travel and meals) as described below.
- Under special circumstances, the Spanish Federation may pay the International Chair Umpire´s fee if requested by the CEAT.
- The number of workdays will depend on the assignments in accordance to the factsheet and/or the official letter submitted to the tournament by the CEAT. The weather or any issue not directly related to the official will not deduct any workday.
- If a tournament deviates from the sanctioned dates, the organising committee will be responsible for paying the extra charges required to adjust the travelling dates.
- If an official works 5 days or less, his/her total fee will depend on the number of days.
- At combined ITF Pro Circuit events the Supervisor/Referee´s fee shall be increased by 20%.

Other expenses: *(Applied to not local officials appointed by the CEAT)*

SUPERVISOR, REFEREE AND CHAIR UMPIRES:

- **Travel expenses:** *(Procedures for officials appointed by the CEAT shall be applied)*
 - By car: 0,19 €/Km plus toll roads.
 - By motorbike: 0,078 €/Km. plus toll roads.
 - If an official lives 35 km or less away from the venue, he/she will not receive any amount per km.
 - Other transport: the amount of the ticket plus the relevant expenses.
- **Meals and per diem allowances:** *(Procedures for officials appointed by the CEAT shall be applied)*
 - All the officials (local and not local officials) who work during the whole day will have lunch at the venue, and not local officials (and local umpires if needed) will receive a 25 € per diem allowance subject to show the relevant tickets.
- **Accommodation:** *(Procedures for officials appointed by the CEAT shall be applied)*
 - Single room for the Referee and the International Chair Umpire, and double rooms for National and White Badge Chair Umpires. Breakfast shall be included.

LINE UMPIRES AT ATP 1000:

- **Travel expenses:** 15€ per each 100Km from the venue, excluding officials who live in the same county. 150 € for foreign officials and for umpires from islands, Ceuta and Melilla.
- **Meals:** Lunch provided by the tournament. Dinner for not local officials and for locals who work after 21:00 as well.
- **Accommodation:** 15€/night since the arrival day and including the night of the last workday, and excluding all the officials who live in the autonomous community where the tournament takes place.

LINE UMPIRES AT ATP 250 and ATP 500:

- **Travel expenses:** 10€ per each 100Km from the venue, excluding officials who live in the same county. 100 € for foreign officials and for umpires from islands, Ceuta and Melilla.
- **Meals:** Lunch provided by the tournament. Dinner for not local officials and for locals who work after 21:00 as well.
- **Accommodation:** 10€/night since the arrival day and including the night of the last workday, and excluding all the officials who live in the autonomous community where the tournament takes place.

LINE UMPIRES AT WTA AND ATP CHALLENGER TOUR:

- **Travel expenses:** Please consult to the CEAT.
- **Meals:** Lunch provided by the tournament. Dinner for not local officials and for locals who work after 21:00 as well.
- **Accommodation:** Please consult to the CEAT.

Additional Rules:

- ² If all the matches are postponed then national chair umpires shall be paid according to the length of time they wait ready to work:
 - If waited less than 2 hours - 0 €
 - If waited between 2 and 4 hours - 1 match
 - If waited more than 4 hours - 2 matches
- If the local officials are appointed by a local officiating committee, their accommodation, travel and meal expenses are regulated by the appointing committee.
- The Tournament may provide clothing to the assigned officials.
- Tax duties shall be applied to the relevant fees.
- Any matter not covered in the current regulations shall be decided by the CEAT.
- The fees shall be reviewed on an annual basis and in accordance to the CPI (consumer price index).
- Depending on the tournament format, special fees and/or conditions may be approved.
